Appointed to command 6<sup>th</sup> Battalion, Gloucestershire Regiment, 1917. Served on Western Front, 1916-1917, and in Italy. Commanded 1<sup>st</sup> Battalion, c.1933-1935. Appointed Commander of 149<sup>th</sup> (Northumberland) Infantry Brigade, 1935.

SCOTT, LIEUTENANT COLONEL L D, 1914-1918

Born, c.1895. Enlisted, c.1914. Served as Adjutant with 7<sup>th</sup> (Service) Battalion during World War I. Appointed second in command, Jul 1917. Commanded the Battalion, Aug-Sep 1917 and Dec 1917-Feb 1918. Awarded Military Cross, 1916.

SEAMAN, PRIVATE W E (1911-?), 1943

Born, 1911. Enlisted at Kingston, 1939. Served with 1/6<sup>th</sup> Battalion in France, 1940. Wounded, May 1940, and a prisoner of war, 1940-1943. Discharged, 1943.

Born in Grays Hill near Chelmsford, Essex, c.1823. Attested, Feb 1841. Served with 62<sup>nd</sup> Regiment of Foot. Joined 70<sup>th</sup> Regiment, Sep 1841. Discharged, 1862.

SEYMOUR, PRIVATE LEONARD WALTER JOHN (1914-1942), 1935-1998

Born, 1914. Enlisted, 1934. Served with 2<sup>nd</sup> Battalion. Posted briefly to 1<sup>st</sup> Battalion, 11 Dec 1935. Returned to 2<sup>nd</sup> Battalion, 28 Dec 1935. Posted to 11<sup>th</sup> Infantry Division, Apr 1941. Returned to 2<sup>nd</sup> Battalion, Jun 1941. Presumed killed in action, 1942.

This file also refers to Seymour's brother, Horace Seymour, who served with 1/6<sup>th</sup> Battalion, and an unnamed second brother, who served with the Royal Horse Artillery.

SHIELS, PRIVATE MICHAEL (1915-?), 1930S-1961

Born, 1915. Enlisted, 1935. Served with 2<sup>nd</sup> Battalion in India, 1936-1937, Sudan, 1937-1938, China, 1938-1940, Singapore, 1940-1942. Was a Japanese prisoner of war, 1942-1945. Transferred to reserve, 1946. Discharged, 1961.

SIDWELL, PRIVATE LESLIE GEORGE, 1938-1958

Enlisted in London, 1931. Served with 1<sup>st</sup> Battalion in India, 1933-1937, and England, 1937-1938. Transferred to reserve, 1938. Recalled, Jun 1939, and served with the East Surrey Regiment until Nov 1939. Served with the Queen's Royal Regiment (West Surrey), Nov 1939-1943. Served with the Somerset Light Infantry as part of the British North African Forces, 1943-1945, and in England, 1945-1946. Transferred to reserve, 1946. Discharged, 1958.

Born in Basingstoke, c.1881. Enlisted in Kingston on Thames, Mar 1902. Served with 2<sup>nd</sup> Battalion in South Africa. Discharged, Aug 1902. Later served as a fireman, and was killed when he fell off a moving fire engine and hit his head on the side of the road, 1931.

Born, 1861. Commissioned as a Lieutenant, 1882. Served with 2<sup>nd</sup> Battalion. Served in Sudan with Mounted Infantry, 1885. Served with Egyptian Army, 1896-c.1898. Served with 2<sup>nd</sup> Battalion in South Africa, 1900-1902, and during World War I. Retired, 1918. Died, 1945.
